DESCRIPTION

This is professional work in which the incumbent would be required to provide disability support transition unit services. This includes disability advocacy and advising, career and vocational assessments, policy development, dropout prevention programs, preparing and monitoring Individualized Transition Plans (ITPs) providing training and assistance to vocational education staff, provide college/technical school tours, applications, Career to Work Placement, and referral for testing and additional services. Work involves responsibility for supervising and coordinating district level activities in this unit. The person selected is also required to provide individualized assistance in accordance with the students Individual Transition Plans (ITP) in employment and college/technical level study skill development for all students with disabilities. Provide assistance in developing, implementing, coordinating and developing policies that support comprehensive, student-centered initiatives that reflect post-secondary thinking, foster student retention and promote the holistic development of students. The Career Development Manager will be a member of the administrative staff under the supervision of the District Director of Special Services

DUTIES AND RESPOSNIBILITES (NOT ALL INCLUSIVE)

- Develop, implement and review the goals, objectives, policies, procedures and priorities for the transition unit services;
- Establish and interpret policies and procedures related to the development and refining of the career development process;
- Provide learning strategies and/or coaching services to students with special needs;
- Assist students with disabilities, to understand their cognitive strengths and weaknesses and how they impact their employment and post education learning style;
- Assist in employment/post-secondary education development of appropriate readiness strategies;
- Individualized/group sessions on employment/college skills,, time management, student skills, test anxiety, organization, et;
- Interpreting Vocational Interest and Career Scope Assessments;
- Specific help on School to Work placements and College liaison contact;
- Prepare college/technical school tours for students with disabilities to meet their Individual Transition goals;
- Collaborate with other departments, community job site communities to determine appropriate methodology in meeting the needs of students;
- Compile data and statistics reflecting progress, trends, use of services and appropriate recommendations for future initiatives;
- Perform other duties as assigned.

KNOWLEDGE, SKILLS AND ABILITIES

- You can manage details and consistently demonstrate poise, tact, diplomacy and good judgment;
